Stirling Local Access Forum	<p>TB introduced Richard Barron RB (Stirling Council Access Officer) to the meeting. RB gave a short presentation on the role of the Stirling Local Access Panel. The Land Reform Act requires that every Local Authority and National Park has a legal obligation to set up an Access Panel. The panel is made up of three representative groups, Business, Community Groups, National Organisations. The group was re-launched in 2006 and has two roles.</p> <ul style="list-style-type: none"> ▪ As an advisory panel to the council ▪ To act as an arbitrator for any disputes that may arise. <p>To date the panel have produced a strategy for the council on Access to the Countryside. Involvement in the CORE paths plan.</p> <p>The forum is keen for representatives with disabilities, who would bring different perspectives to the meetings, to sit on the steering group and RB issued an open invitation to SAAP members.</p> <p>RB then answered a number of questions from the group. The panel thanked RB for his time and he left prior to business.</p>

<p>MATTERS ARISING</p>	<p><u>Access Audits</u></p> <p>DMH not present, will feed back re: reply from Tom Lister at next meeting.</p> <p>Keith Robertson (SDEF) has agreed to meet with TB to carry out an Access Audit of the Peak Centre.</p> <p>There is still an issue about access to the facility after 6pm when public transport stops. Group agreed that Community Councils need to be approached to send letters about this issue to relevant parties such as local press.</p>	<p>DMH</p> <p>TB</p> <p>TB & JC</p>
	<p><u>Leaflet</u></p> <p>MM showed concern that the group want to blanket recruit volunteers onto the Panel. She felt that too many members on the panel would maybe make it slightly unmanageable. It was suggested that an application form be produced for potential volunteers showing what strengths, experience and expertise they would bring to the panel. This would ensure a wider skills base within the panel.</p>	<p>ALL</p>
	<p><u>Strathard Trust Action Plan</u></p> <p>Aberfoyle Community Council have drafted and sent a letter to Stirling Council raising concerns relating to pavements. John will feedback council response at next meeting.</p>	<p>JC</p>
	<p><u>Public Transport</u></p> <p>DMH to invite Brian Peat to be guest speaker at the SAAP AGM to be held on September 2nd at the Bannockburn Centre from 7pm until 9pm.</p> <p>TB completed and sent application form for SAAP to become members of SATA.</p> <p>LW raised the issue around guides who support disabled individuals on public transport, re: national rail. There was great concern that some councils were willing to pay a subsidy to cover the costs of the guides' fares but not all. Most notably if you access a train in Stirling the guide has to pay a fare, but there is no cost when accessing the same train from a Falkirk station. RNIB have produced a list of local authorities that pay this subsidy. TB agreed to investigate this issue via SATA.</p>	<p>DMH</p> <p>TB</p>

LS to send signed copies to Bruce Crawford MSP.</p> <p><u>OPEN DAY</u></p> <p>Panel agreed to the proposal of an Open Day Event at the Norman MacEwan Centre to launch SAAP. COD, CVS Stirling and CAB will be involved in the day. TB to apply for funding for the event through Stirling Council's Community Grant Scheme.</p> <p><u>Traffic Lights at Goosecroft Road</u></p> <p>AC stated that the new traffic lights at Goosecroft Road take an extremely long time to change.
